We offer two types of membership to meet your needs – full (£30 per year) and associate (£10 a year).

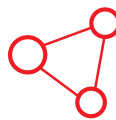

## The Direct Debit Guarantee

If you request England and Wales Cricket Board Ltd to collect a payment, confirmation of the amount and date will be given to you at the time of the request
- If an error is made in the payment of your Direct Debit, by England and Wales Cricket Board Ltd or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society
