GIRLS' CAG REGISTRATION REGULATIONS

INTRODUCTION

These Girls' CAG Registration Regulations ("Regulations") come into full force and effect on the Effective Date.

These Regulations set out the eligibility criteria, enrolment and player movement provisions relating to Girls' CAG Players. Each County responsible for delivering a Girls' CAG Programme has an obligation to promote, protect and support the individual wellbeing of each player on its Girls' CAG Programme and the collaborative aims of the Talent Pathway Catchment Areas to ensure seamless transitions for players through the talent pathway. Where any Girls' CAG Player is under the age of 18, each County must ensure that the Girls' CAG Player's parent/carer is provided with appropriate information and gives their consent to the Girls' CAG Player's participation in the relevant Girls' CAG Programme. Where any of these Regulations require a Girls' CAG Player to take some action (for example, give notice to a County), that action can be performed by the Girls' CAG Player's parent/carer on their behalf where the player is under 18 years old. Any approach or notice by a County to a Girls' CAG Player that is under the age of 18 must be made or given (as appropriate) to the parent/carer of the player.

DEFINITIONS

In these Regulations, unless otherwise specified, defined terms have the meanings as set out in the Tier 1 Registration Regulations and as set out below.

"County" means a Tier 1 County, Tier 2 County or Tier 3 County which runs a Girls' CAG Programme.

"Current County" means the County a Girls' CAG Player is currently enrolled with.

"ECB Competition" has the meaning given to it in the ECB GCR.

"ECB GCR" means the General Conduct Regulations which are applicable to ECB Competitions as in force and amended from time to time.

"Effective Date" means 4 December 2025.

"Female Only Cricket" has the meaning given to it in the ECB's Player Gender Eligibility Regulations.

"Girls' Academy Programme" means the training and development programme run for young players by Tier 1 Counties and Glamorgan Cricket Club, providing an environment that offers high quality individualised development opportunities and experiences to develop players.

"Girls' CAG Competitions" means the ECB's county age group competitions.

"Girls' CAG Player" means a cricketer enrolled in a Girls' CAG Programme.

"Girls' CAG Programme" means the training and match play programme for girls aged predominantly 12 to 17 years, to provide learning and development opportunities. For the purposes of these Regulations, unless otherwise specified in a particular Regulation, any reference to a Girls' CAG Programme will include any participants aged under 12 or over 17 where their participation has been permitted in accordance with the requirements of Regulation 1.1.

"Girls' Emerging Player Programme" means the programme of support to players aged predominantly 13 to 18 years to develop basic foundations of future performance through an individualised programme of development.

"Head of Talent Pathway" means the person employed by a County to lead and be responsible for the Girls' CAG Programme.

"Guest Participation Form" means the form to be submitted to the ECB notifying the relevant ECB Competitions Officer that agreement has been reached for a Girls' CAG Player to play for a Team other than the Team of their Current County during the term of their enrolment in a Girls' CAG Programme.

"Professional County Club" means any of the clubs and/or companies from time to time listed in Schedule A to the ECB's articles of association and/or any county cricket club from time to time playing in the County Championship and/or the Tier 1 Competitions and/or the Tier 2 Competitions.

"Recreational Cricket Board" means a body designated as such by the ECB which is responsible for the organisation of recreational cricketing activity and the development of cricket generally within a county and such other areas (if any) as may be agreed by the ECB.

"Talent Pathway Catchment Area" means a group of Counties as defined by the ECB from time to time, who are required to work collaboratively with each other to develop the girls' talent pathway.

"Team" means any senior team of a Tier 1 County, Tier 2 County or Tier 3 County, or any team formed as part of a Girls' Academy Programme, Girls' Emerging Player Programme or Girls' CAG Programme.

"Tier 1 Competitions" means any women's domestic cricket competitions designated by the ECB as being a "Tier 1" competition, which, as at the Effective Date, includes the T20 Blast Women's Competition and the One Day Cup Women's Competition.

"Tier 1 County" means a Professional County Club that participates in the Tier 1 Competitions.

"Tier 1 Registration Regulations" means the regulations governing, amongst other things, registration for the Tier 1 Competitions as in force and amended from time to time.

"Tier 2 Competitions" means any women's domestic cricket competitions designated by the ECB as

being a "Tier 2" competition, which, as at the Effective Date, includes the T20 Blast Women's League 2 and the One Day Cup Women's League 2.

"Tier 2 County" means a Professional County Club that participates in the Tier 2 Competitions.

"Tier 3 Competitions" means any women's domestic cricket competitions designated by the ECB as being a "Tier 3" competition, which, as at the Effective Date, includes the T20 Blast Women's League 3 and One Day Cup Women's League 3.

"Tier 3 County" means a Recreational Cricket Board which (i) operates in a county without a Professional County Club and (ii) runs a team which participates in the Tier 3 Competitions.

1. ELIGIBILITY

- 1.1. Subject to the annually agreed exemption for overaged players, which is agreed at the ECB's sole discretion, cricketers seeking to participate in the Girls' CAG Programme must be aged between 12 and 17 (inclusive) at midnight on the 31 August immediately prior to enrolment. If a cricketer aged 11 or under wishes to enrol in a Girls' CAG Programme, the County must be satisfied that the cricketer is of an appropriate level of skill and maturity to participate and, if so, the County must adhere to these Regulations in relation to that cricketer.
- 1.2. Cricketers will be enrolled in a particular age category within the Girls' CAG Programme and must be the relevant age for that age category. For example, cricketers who are aged 12 as at midnight on the 31 August immediately prior to enrolment will be classed as under 13 players.
- 1.3. Eligibility to participate in fixtures in a different age category in an ECB Competition will be governed by the competition regulations applicable to the relevant ECB Competition. If a cricketer wishes to participate in training and fixtures in a different age category outside an ECB Competition, the following rules apply:
 - 1.3.1. If a cricketer is seeking to "play up", the County must be satisfied that the cricketer is of an appropriate level of skill and maturity to participate at that level; and
 - 1.3.2.If a cricketer is seeking to "play down", prior agreement must be reached by the Head of Talent Pathway for both participating Counties in the relevant fixture.
 - In each case, the cricketer's participation in any fixture must be permitted under any applicable competition regulations.
- 1.4. Subject to the overriding discretion of the ECB, a cricketer will be eligible to participate in training and match play as part of a Girls' CAG Programme if:
 - 1.4.1.the cricketer is resident within the County of the Girls' CAG Programme in which they

- seek to participate (whether through being permanently resident in that County or otherwise residing in that County for the duration of the season); or
- 1.4.2.the cricketer was born within that County; or
- 1.4.3.the cricketer is attending an educational establishment within that County (other than as a temporary exchange student); or
- 1.4.4.the cricketer has been a playing member of a club within the County of the Girls' CAG Programme in which they seek to participate for at least one prior full season; or
- 1.4.5.the cricketer has participated in that Girls' CAG programme during a previous season; or 1.4.6.the provisions of Regulation 1.5 apply.
- 1.5. Where a cricketer does not meet the requirements prescribed by Regulation 1.4.1 to 1.4.5 above, the cricketer may still be permitted to enrol on a Girls' CAG Programme other than one they are eligible for under Regulation 1.4.1 to 1.4.5, where there is agreement between the cricketer, their parent/carer and the relevant Counties, that it is in the cricketer's interests for them to enrol and participate in a Girls' CAG Programme run by another County. For the purposes of this agreement, the relevant Counties will be the County (or Counties) the cricketer would otherwise be eligible for, in accordance with Regulation 1.4, and the County running the Girls' CAG Programme that the cricketer is seeking to enrol in. Such agreement must not be unreasonably withheld, but any ongoing disagreement will be determined by the ECB in accordance with Regulation 6.
- 1.6. The provisions of the ECB's Player Gender Eligibility Regulations will apply to these Regulations and the Girls' CAG Programme is classified as Female Only Cricket.

2. ENROLMENT PROCESS

- 2.1. Each County may enrol an unlimited number of Girls' CAG Players on their Girls' CAG Programme in each age group from under 13 to under 18, including any Girls' CAG Players aged 11 or under where the County is satisfied that the cricketer is of an appropriate level of skill and maturity to participate. The County must adhere to these Regulations in relation to all such cricketers.
- 2.2. A Girls' CAG Player may only be enrolled in one County's Girls' CAG Programme at any given time and must not play for any Girls' CAG Team other than the Girls' CAG Team of their Current County unless the requirements of Regulation 2.3 are met.

- 2.3. Agreement may be reached for a Girls' CAG Player to play for another Girls' CAG Team in addition to the Girls' CAG Team of their Current County during the term of their enrolment provided that:
 - 2.3.1.the two relevant Counties participate in different divisions of the player's age category, or the Girls' CAG Player is seeking to play in a different age category available with another County;
 - 2.3.2.the Girls' CAG Player's Current County gives permission, which must not be unreasonably withheld;
 - 2.3.3.the ECB, the two relevant Counties, the Girls' CAG Player and the Girls' CAG Player's parent/carer are all satisfied that it would be in the Girls' CAG Player's best interests;
 - 2.3.4.the two relevant Counties have agreed how the player's participation in both Girls' CAG Programmes will be managed through the season; and
 - 2.3.5.the ECB has been notified of the agreement via submission of the Guest Participation Form to the ECB Competitions Officer responsible for the Girls' CAG Competitions.
- 2.4. A Girls' CAG Player's enrolment on a Girls' CAG Programme will last for one season only and will therefore expire on 31 October unless it is terminated earlier in accordance with Regulation 3.

3. TERMINATION OF ENROLMENT

- 3.1. The enrolment of a Girls' CAG Player pursuant to these Regulations may be terminated as follows:
 - 3.1.1 At any time, by the Girls' CAG Player providing written notice to the Head of Talent Pathway that the Girls' CAG Player will no longer be participating in that County's Girls' CAG Programme. Where termination is being requested during the "competition phase" (April to September), the Girls' CAG Player must take all reasonable steps to notify the County 14 days in advance of the Girls' CAG Player ceasing to train with and/or play for their Current County. The County must notify the ECB when the Girls' CAG Player's enrolment has terminated.
 - 3.1.2 At any time, by the County providing written notice to the Girls' CAG Player and notifying the ECB of the termination. In such circumstances, the Girls' CAG Player's enrolment with their Current County will terminate immediately (or an alternative later date agreed between the County and the Girls' CAG Player).

- 3.2 In all instances, the Girls' CAG Player and their parent/carer are encouraged to have discussions with the Current County to discuss why the enrolment is being terminated and/or the Girls' CAG Player's participation in the Girls' CAG Programme has ended.
- 3.3 Once a Girls' CAG Player's enrolment with a County has been terminated in accordance with this Regulation 3, that Girls' CAG Player is entitled to enrol with the Girls' CAG Programme of another County.

4. PLAYER MOVEMENT AND APPROACHES

- 4.1 A County must not approach, or otherwise be involved in discussions with, any Girls' CAG Player (or any person acting on a Girls' CAG Player's behalf) that is enrolled with another County with a view to offering that Girls' CAG Player a trial or registering, enrolling or engaging them in any capacity, on their Girls' CAG Programme, Girls' Emerging Player Programme or Girls' Academy Programme save in relation to any agreement reached in accordance with Regulation 2.3 or as otherwise permitted by Regulation 4.2.
- 4.2 A Girls' CAG Player (or any person acting on a Girls' CAG Player's behalf) may approach, or engage in discussions with, a County they are not currently enrolled with about that other County offering the Girls' CAG Player a trial or registering, enrolling or engaging them in any capacity, on their Girls' CAG Programme, Girls' Emerging Player Programme or Girls' Academy Programme only where:
 - 4.2.1 the Girls' CAG Player has first notified their Current County of their intention to approach another County. In such circumstance the Girls' CAG Player may make an approach to another County and that County may enter into discussions, but must not make the initial approach; or
 - 4.2.2 the Girls' CAG Player or their Current County has provided a termination notice in accordance with Regulations 3.1.1 and 3.1.2 (as applicable).
- 4.3 If a County wishes to approach a Girls' CAG Player it must check the enrolment status of the player with the previous County the player was enrolled with, if known, and ensure that it complies with Regulation 4.1. If that player is still enrolled the County must only approach the player's Current County's Head of Talent Pathway in the first instance rather than approaching the player (or any other person acting on the player's behalf). Any approach to a player under the age of 18 permitted under this Regulation 4 must be made to the parent/carer of the player.

- 4.4 Subject to Regulation 4.5, a player is not eligible to be enrolled or registered with more than one County across the Girls' CAG Programme, Girls' Emerging Player Programme or Girls' Academy Programme.
- 4.5 Where a player is enrolled in the Girls' CAG Programme for a Tier 1 County, Tier 2 County or Tier 3 County, that player will still be eligible to be registered for the Girls' Emerging Player Programme or Girls' Academy Programme for a different Tier 1 County or Tier 2 County (as applicable).

5. PARTICIPATION IN MATCHES

- 5.1. The following players can participate in matches in the Girls' CAG Programme:
 - 5.1.1.Girls' CAG Players who are enrolled with that Girls' CAG Programme in accordance with these Regulations;
 - 5.1.2.Players who are registered with the Girls' Academy Programme the Girls' CAG

 Programme is associated with, provided that the ECB's Women's Cricket Pathway

 Leadership Team has granted permission in advance of the match (which will be

 considered on a case-by-case basis); and
 - 5.1.3. Players who are registered with the senior Women's team of the Tier 1 County, Tier 2 County or Tier 3 County the Girls' CAG Programme is associated with, provided that the ECB's Women's Cricket Pathway Leadership Team has granted permission in advance of the match (which will be considered on a case-by-case basis).

6. DISPUTES

Any unresolved dispute concerning player eligibility and/or enrolment will be referred to a panel of three members of the ECB's Performance Cricket Committee ("PCC"), or those persons to whom the PCC has delegated responsibility for the purposes of this Regulation 6, whose decision will be final and binding on the parties to the dispute (the "Panel"). The Panel may follow such procedure as it considers appropriate and will not be bound by rules governing the admissibility of evidence in judicial or other proceedings. The ECB's National Talent Managers will not sit on the Panel.
