<b>Your right to withdraw consent</b>	Where you have given your consent to any processing of personal data you have the right to withdraw that consent at any time. If you do, it will not affect

<b>Location of your personal data</b>	We will each keep your personal data within the European Economic Area.
<b>How long we will keep your personal data for</b>	We will normally keep your personal data for 2 years. After this time period your personal data will be securely deleted.
